As the coronavirus (COVID-19) situation continues to evolve so does our focus on serving you.

With the social distancing protocol we have all been practicing, we believe the fresh mountain air and the great outdoors will provide a great escape from the stress of this new, but temporarily modified lifestyle. We, along with the state of NH feel that it is still possible to go camping so you can enjoy the awesome mountain hiking and fishing this season. Working together to be safe by keeping our group numbers reduced, and staying away from others if you are symptomatic will help ensure that the spread of this virus is reduced.

As this situation evolves, we will modify this statement as needed. Please be safe, and we wish anyone who is dealing with this outbreak a speedy recovery.

All of our sites and available cabins are open! Most of our facilities are also open! Please read the remainder of this statement carefully so you understand how New Hampshire's state guidelines for campgrounds will affect our operation and your stay with us. *(This is not a legal document, but rather an outline for our customers to use in understanding how the state guidelines apply to this property. This document is subject to change or be revised without notice. Along the River Campground and Cabins will do its best to provide a safe environment for you, your family, and friends. We do not, and can not guarantee 100 percent safety.)*

NH Reopening

How our physical property/business conforms to the guidelines:

Out of state guests are NOW allowed providing that no one in your party is feeling ill. Anyone from outside the New England States are required to sign a document stating that you and everyone on your reservation has self isolated for 14 days prior to arrival while maintaining all the social distancing and Covid-19 health guidelines. This restriction is subject to revision as the Covid-19 environment gradually improves. Please do not hesitate to contact us regarding your camping plans throughout this season especially if you are from out of state.

The following campground features/areas are closed until further notice:

Game Room - Horse shoes

The following are NOW OPEN!

Swimming Pool - Playground (swings and sand box etc.) - River & Community Picnic Area

The following features/areas are open with restrictions as noted:

General:

- Outside visitors are NOW allowed at the campground.
- Seasonal Campers are permitted.
- Outdoor Areas have a maximum group size of 10 people and it is recommended that cloth face masks be worn and practice 6 feet social distancing. Our outdoor areas refer to our play field, picnic/sitting area by the river access, the river itself, and all camp sites and outdoor cabin areas. Maintain small socially spaced groups of no more than 10.

Pool:

- The current maximum people allowed in the pool is 12. You MUST maintain social distancing at all times while in the pool.
- We are not providing pool furniture at this time. You are welcome to bring your camp chairs to sit and monitor your young children, or layout a blanket on the pool lawn.
- Absolutely NO SPITTING in the pool and pool area.
- No food, drink, or pets allowed in the pool and pool area.

Bath House/Restrooms:

Use/Accessibility:

- Anyone with a self contained unit (camper with bathroom facilities) is required to use their camper's facilities. We need to all work together in order to take the "load" off the bath house and allow access for tenters, pop-ups and tear-drops.
- We are limiting bath house occupancy to 3 people at a time.
- The center toilet stall is closed for use in order to meet 6 feet social distancing.
- Vanity sink area has been modified with a Covid-19 partition to create a safe area for sink use. In addition, new hands free paper towel dispensers have been added along with additional waste baskets to eliminate traffic cross-over.
- Showers are available without modifications

Cleaning:

- We will maintain our standard cleaning window of time. Sometime between 11am and 1 pm we perform our cleaning process. Please, please respect our staff's need to be in there cleaning for you. DO NOT use the facilities while we are doing our job.
- We will augment this cleaning with additional rounds of sanitizing to the common "touch points" throughout the day and into the evening. We will be wiping down handles, hard surfaces and light switches with sanitary wipes and/or sanitary spray cleaners. During these additional sanitizing steps, the bath house facilities will remain "open" so to not create more inconvenience for our guests. We do ask that you be courteous for our needs to clean and allow us the social distance to safely perform this required work for you.
- Face masks are recommended while using the bath house.

Campground Store:

Only one person, or immediate family allowed in the store at a time. (It's a small store.)
We have erected a Covid-19 screen over our sales counter.

Check In Process:

- Pull your vehicle as far forward as possible to allow for other vehicles to enter off the state highway.
- Only one member of your group (site or cabin) is allowed to enter the store. Please wait outside the store until the proceeding guest has completed their business and exited.
- Once you have finished reviewing our required guest and property information with our representative you may return to your group and proceed to your site/cabin.

Ice/Firewood for sale:

- You may purchase ice and firewood anytime the store is open.
 - Ice: we will open the ice cooler and give you the bag(s) of ice you purchased and you can take it to your site/cabin. We will not deliver ice.
 - Firewood: You can purchase firewood, and we will deliver to your site as quickly as possible. You also can call the campground at 603-846-1026 and order/pay for firewood over the phone (\$10.00 minimum credit card charge).

Retail Store Items:

- Our store is stocked with quite a few different things to make your stay more enjoyable. Browse quickly because we only can allow for one customer at a time in the store. Only touch what you are going to purchase.

Campsites:

River and Tent sites:

- Our sites are open and available, please limit the number of other fellow campers to 6-8 as the state guidelines recommend. Maintain social distancing and the state recommends wearing face masks.
- Our staff will sanitize the “touch areas” of each site between users.

RV sites:

- RV sites are full hook-up (water, electric, and sewer). Please limit the number of other fellow campers to 6-8 as the state guidelines recommend. Maintain social distancing and the state recommends wearing face masks.
- Our staff will sanitize the “touch areas” of each site between users.

Cabins:

- Our cabins are open and available this season. We have enhanced our cleaning process as per recommended guidelines. Cabins will be sanitized between guest stays. Please follow our check in and check out times to allow us enough time for our staff to prepare the cabins for you.

Reservations must be made on-line or by telephone and paid in full prior to your arrival and check-in. Walk-in registrations are not allowed.
